The Government of the Republic of Iraq has received an ODA loan from the JAPAN INTERNATIONAL COOPERATION AGENCY (JICA) towards the cost of PORT SECTOR REHABILITATION PROJECT (II), and intends to apply a portion of the proceeds of the loan to payments under this Package 1C Port Facility Rehabilitation at KZP.

The GENERAL COMPANY FOR PORTS OF IRAQ (GCPI), as the Executing Agency of the Project hereby invites interested specialist contractors, who wish to be included in the mailing list to receive an invitation to bid, to submit their Expression of Interest (EOI).

Scope of work:

The scope of the works under Package 1C Port Facility Rehabilitation at KZP consists of following items;

Construction of Parking Area

- Construction of approximately 50,000 m² concrete paved parking area for trucks
- Construction of buildings at the parking area:
 - Cafeteria
 - Administration building
 - Laundry
 - Toilet and shower buildings
 - Workshop
 - Utility House
- Construction of water supply, drainage, and sewage, and power supply for the parking area and buildings

Requirements

The key conditions of acceptance for the bidders are as follows:

- A. *Annual turnover of construction work* of at least Fifteen (15) Million in US Dollars (USD 15,000,000).

- B. *Experience as prime contractor* (single entity or JV member), subcontractor, or management contractor (i) for at least the last five (5) years from 2012 to 2016, starting 1st January 2012.
- C. *Proposals for the timely acquisition* (ownership, lease, hire, etc.) of the essential equipment listed below;
 - a) Motor Graders (approximately 3.5-meter wide blade): 2 Nos.
 - b) Vibrator Roller Compactor (minimum capacity 10 ton); 6 Nos
 - c) Rubber Tire Roller (minimum capacity 10 ton); 2 Nos
 - d) Concrete Batching Plant with integrated mixer (30m³ per hour): 2 Nos.
- D. *A Contract Project Manager and leading Engineers* for electrical and mechanical works with five (5) years' experience in works of an equivalent nature, and other staff requirement as detailed in the Bidding Documents; and
- E. *Liquid assets and/or credit facilities*, net of other contractual commitments and exclusive of any advance payments which may be made under the Contract, of no less than Four Million US Dollars (USD 4,000,000).

Post-qualification

In addition to above requirements, the following issues will be subject to post-qualification.

- 1) Historical Contract Non-Performance
- 2) Financial Situation
- 3) Construction Experience
- 4) Financial Resources

Information about Type of Bidding Documents and Contract.

The Bidding Documents and Contract will be in conformity with JICA standard for "Procurement of Small Works"

GCPI Right to Accept or Reject

GCPI may accept or reject any applicant according to the above requirements and/or other company data received/obtained by GCPI.

Expected start of bidding and duration of the works

This Expression of Interest stage will be followed by a National Competitive Bidding (NCB) process with the following expected milestones:

- A. Bidding Documents to be issued on: Thursday, April 27th, 2017.
- B. Bid Closing and Bid Opening: Monday, June 12th, 2017.
- C. The works to commence on November 5th 2017.
- D. The duration of the works: 365 days.

EOIs must be delivered to the General Company for Ports of Iraq at the following address by Wednesday, **April 26th, 2017, 14:00 hours, Iraqi time**. EOIs received by mail, courier service, e-mail or delivered directly to the address below are acceptable.
